- d) Fradulant on obligations regarding the payment of direct and indirect taxes in accordance with the applicable regulations in B&H or the country in which it is registered.

In this regard, I am aware of the obligation of the candidate / bidder to submit the documents referred to in Article 45, paragraph (2), items a) to d) at the request of the contracting authority and within the deadline determined by the contracting authority pursuant to Article 72, paragraph (3). point a).

I further declare that I am aware that forgery of an official document, i.e. the use of a false official or business document, book or file in the service or business as true is a criminal offense under the Criminal Code of B&H, and that giving incorrect information in documents proving personal ability from Article 45 of the Law on Public Procurement is a misdemeanor for which fines from 1,000.00 KM to 10,000.00 KM are provided for the bidder (legal entity) and from 200.00 KM to 2,000.00 KM for the responsible person of the bidder.

I also declare that I am aware that the contracting authority conducting the said public procurement procedure pursuant to Article 45, paragraph (6) of the Law on Public Procurement of B&H in case of doubt in the accuracy of data provided through this statement reserves the right to verify the accuracy of information.
